Initial Basic Fees

All ATA Carnets are assessed a Base fee. The Base fee is calculated based upon the total value of the General List. The fee covers the first page of the General List and up to four sets of counterfoils and corresponding vouchers (U.S., foreign, or transit).

The United States Council for International Business (USCIB) generally requires a security amount of 40% of the total General List value. Security can be posted in the form of cash or a surety bond. Click the “?” icons below to learn more about various premiums that may affect your application.

Calculating Carnet Bond Amounts

General List without Vehicles:	Bond must cover this percentage of carnet value:	40%
General List with Vehicles (for Corporations):	Bond must cover this percentage of carnet value:	100%
General List with Vehicles (for Individuals):	Bond must cover this percentage of carnet value:	150%

Calculating Carnet Bond Premiums

Bond Premium is generally assessed at 1% of the amount calculated above, with a minimum of \$50.

Calculating Cargo Insurance Premiums

Cargo Insurance Premium is based on carnet travel plans as described below, with a minimum of \$100.

# of Planned Visits or Transits Abroad:	Multiply Total Value of Goods By:
1 – 3	0.80%
4 – 7	1.05%
8 – 11	1.55%
12– 15	1.80%



Replacement Fee Schedule

Effective February 1, 2016

Use this Fee Schedule as a guide to determining the costs for obtaining a Replacement ATA Carnet and ATA Carnet-related services. Applications must be submitted with the application fee of \$275, plus security per the Premium Schedule on the following page. If, for any reason, the United States Council for International Business (USCIB) is unable to obtain authorization from foreign custom to issue a Replacement Carnet, you will received a refund less a \$125 service fee. Your total fees will be based upon the following schedule:

Replacement Processing Fees

Replacement Application Fee	\$275
Replacement Activation Fee	\$175

Basic ATA Carnet Fees

All ATA Carnets are assessed a Base fee. The Base fee is calculated based upon the total value of the Replacement Carnet's General List. The fee covers the first page of the General List and up to four sets of counterfoils and corresponding vouchers (U.S., foreign, or transit). The fee schedule does not include required security fees such as cash deposits or bond premiums; please see the attached ATA Carnet Premium Schedule or contact your Carnet Service Representative for details.
