- Penalties: For goods that are not re-exported, penalties may reach a maximum of three times the value of the goods. Roanoke is seeking further clarification on this matter.
- Late Re-exportation: All ATA Carnet goods not being re-exported timely from Bahrain by the stipulated date of re-exportation must advise the authorities in advance at the following address. Be sure to note the ATA Carnet number in all correspondence.

- One Set of Blue Transit Counterfoils: Necessary when moving goods from the port-of-entry customs to another inland customs office within China.
- Electronic Data Registration: A Requirement by Chinese Customs on the ATA Carnet:
- Freight shipments – It is the responsibility of the customs broker or freight forwarder in China to complete the data registration process with CCPIT/CCOIC (the Chinese National Guaranteeing Association) prior to customs clearance of the goods. Your local representatives may visit [www.atachina.org](http://www.atachina.org) (website in Chinese) for more details.
- Hand carried merchandise – Chinese customs will stamp the ATA Carnet; however, the Holder must visit CCPIT/CCOIC to complete the data registration within three working days. Ask Customs at the port of entry where the closest CCPIT/CCOIC office is.
- Extension Beyond “Final Date of Re-exportation” (See Item 2 of Importation Counterfoil):
- Chinese customs typically restrict ATA Carnet entries to six months.
- Vehicles Subject to Import Licenses:
- Vehicles entering China for an exhibition or fair must be re-exported immediately, or obtain an import license issued by the Ministry of Commerce in China.
- Used vehicles or right-rudder vehicles need to obtain approval before entry into China.

# Israel (IL)

Israeli Customs requires photographs of the jewelry and watches entering Israel on the ATA Carnet Effective January 15, 2015. However, the instructions provided in handling the ATA Carnet validation and the merchandise are unclear. In the meantime, the Israeli guaranteeing association is checking with their authorities and we hope to receive clarification as soon as possible. Israel Customs strictly controls temporary importations and requires that all items with serial numbers have these serial numbers noted on the ATA Carnet general list.

Until further notification please be advised that the following is what USCIB understands to be the new procedures:

1. Prior to the departure from the U.S., the ATA Carnet Holder must first appoint and schedule a meeting with an authorized Secured Forwarder in Israel to handle the customs clearance.
2. The three authorized Secured Freight Forwarders by Israeli's authorities are:

  - [Malca-Amit](#)
  - [Brinks](#)
3. Upon arrival at the airport in Israel, the ATA Carnet Holder or their representative must go through the RED-Line section (Goods to Declare) at Customs to register and to pack the diamonds into a special secured plastic bag.
4. After the registration and packing, the ATA Carnet Holder or their representative should meet with the pre-arranged forwarder and hand over the bag of diamonds to the forwarder.
5. It is the ATA Carnet Holder's responsibility to schedule the meeting with a secured forwarder at the airport.
6. The secured forwarder will handle the customs clearance at the Diamond-Exchange in Ramat-Gan where evaluation takes place by a special diamonds expert representing the Ministry of Economy of the State of Israel.
7. The forwarder will call and notify the ATA Carnet Holder or their representative of where to collect the goods.  
The process will take a few hours, but the goods will be returned within the same day.

Please be aware that according to USCIB, the registration process noted above in item 3 is where the ATA Carnet validation will take place.

We still have not received clarification on whether this new rule will also affect the procedures for re-exportation. We recommend the ATA Carnet Holder or their representative should check with their freight forwarder for proper guidance.

New Requirements for Hauliers (Freight Forwarders) as of Jan 1, 2022

- The goods vehicle movement Service (GVMS)- any hauliers crossing into or out of the UK, via any port, will need to register for the service to get their goods through customs.
- ATA Carnet number should be entered in the "Declaration Reference" field for the GVMS declaration. This is only required for vehicles using the freight route (i.e. trucks over 7.5t etc.) and must be completed by both empty and full vehicles. Any vehicles going via the passenger route (i.e. cars and small vans) do NOT require GVM.
- Harwich Port-AS of January 1 2022, hauliers passing via the freight terminal will need to lodge a Customs Clearance Request before arriving at the port. Form C21 will allow hauliers that do not have access to the UK Customs system to lodge a request. (note that shipments via Calais and Dunkerque do NOT need to lodge this request.)

- Actual or estimated karat weight for each item should be listed in the description of the goods on the general list. Total weight should be listed in column D.
